Dear Mr. Mendes,

The Judiciary of Trinidad & Tobago is working to refurbish and reopen the San Fernando Magistrates' Court Building. To help improve the provision of its services in the meantime, the Judiciary has taken a decision to transfer the services of the San Fernando Magistrates' Court, which are currently being offered at the Madinah Building, to the San Fernando Supreme Court Building, with effect from Tuesday 3rd April 2018 until the end of the 2017-2018 Law Term. Please allow me to share with you and your association, the implications of this for attorneys and their clients.

Registry Services:

Cash services including the payment of fines and compensation which would be normally done at "San Fernando Magistrates Court (Old Court)", will now be provided at the "San Fernando Supreme Court" building from 8:00 a.m. to 4:15 p.m. (Mondays – Thursdays) and 8:00 a.m. to 4:00 p.m. on Fridays.

Madainah Building:

All services which were offered at the Madinah Building before the operations of the San Fernando Magistrates' Court moved to the Madinah Building, such as services related to Family Matters, payment of traffic related fines etc., will continue to be provided at the Madinah Building.

Before closing, please allow me to also share that the Judiciary of Trinidad & Tobago is also working to improve its operations and the quality of service not only through "brick and mortar" projects but also through process improvement and technology driven projects. Two such examples, about which more information will be communicated to you and the members of your Law Association soon, are the "Probate Modernization Project" and the "CourtPay Project". The latter was recently launched by the Honourable Chief Justice and will go live soon.

We shall continue to work to improve our services and keep in regular communication with you and the law Association.
