### NOTICE OF CLOSING DATE FOR NOMINATIONS OF CANDIDATES TO THE 36TH COUNCIL

All Attorneys at Law are advised that:

- The Closing Date for Nomination of Candidates for the positions of Treasurer and Two

   (2) Senior Ordinary Members to the 36<sup>th</sup> Council is <u>Friday 27<sup>th</sup> May 2022 at 12:00</u> noon.
- 2. Nominations for the position of Treasurer and Two (2) Senior Ordinary Members must be made in writing on the prescribed Nomination Form. A separate nomination form is required for each position.
- Nomination Forms can be obtained from the Office of the Law Association located at 2nd Floor 95-97 Frederick Street, Port of Spain and can be downloaded from the Law Association of Trinidad and Tobago's website <a href="http://www.lawassociationtt.com">http://www.lawassociationtt.com</a>.
- 4. Pursuant to paragraph 9(2) of Part II of the Legal Profession Act 1986 only practitioner members who hold a valid practicing certificate for the law term 2021-2022 or who produce a receipt for the 2021-2022 law term with a 2020-2021 practicing certificate are eligible: (a) to nominate candidates (b) to attend and vote at a general meeting or at an election of members of the Council: and (c) to be elected to the Council.
- 5. Every nomination form of a candidate for election to the Association and the Council shall be signed by not less than five practitioner members and endorsed by the candidate.
